Please follow carefully the instructions for the admissions requirements (see page 20 of the catalogue). In order to complete the admissions process, we need the following:

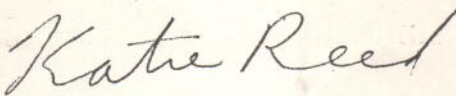
